As a member of the federal Criminal Justice Act ("CJA") panel she served as the national representative for the Southern District of Indiana, 7th Circuit representative and as the Co-Chair of the Defender Services Advisory Group ("DSAG") in Washington, D.C. As the Co-Chair of DSAG she represented over 10,000, CJA federal criminal defense attorneys nationally regarding policies, procedures and legislation.

Doneaka also worked in the Office of Corporation Counsel, where she interpreted and enforced rules and regulations related to zoning in the City of Indianapolis. She ensured

compliance by local businesses and contractors, advised on regulatory obligations, and handled civil witnesses and complaints involving ordinance violations.

From 2019 to 2021, she served as an adjunct professor at the IU McKinney School of Law, teaching and mentoring future legal professionals.
