### ***Trial and Case Highlights***

- In a federal civil rights jury trial, Thomas successfully defended an off-duty police officer who shot and killed a Gangster Disciple who attempted to carjack him. Contrary to Plaintiff's theory, Thomas convinced the jury that the officer's actions were done in a reasonable use of force justified by the defense of himself and his daughter, a passenger in his car.
- In a Cook County Law Division jury trial, Thomas successfully litigated a premises liability case defending the Chicago Housing Authority and its property manager where the Plaintiff asked the jury for more than \$2 million in damages. The jury believed Thomas' experts who explained that Plaintiff's damages were unrelated to her slip and fall in her CHA unit and awarded her only \$68,000.
